Brookside Investors acts by and through its general partner, Brookside Management. Mr. Domenic J. Ferrante is the managing member of Brookside Management and thus is the controlling person of Brookside Management. No person other than the respective owner referred to herein of the Common Stock is known to have the right to receive or the power to direct the receipt of dividends from or the proceeds from the sale of such Common Stock.

As of the close of business on July 30, 2008, the Brookside Fund was the beneficial owner of 5.24% of the Common Stock of the Company. As of the close of business on August 8, 2008, the Brookside Fund was the beneficial owner of 6.20% of the Common Stock of the Company. The aggregate percentage of Common Stock reported owned by the Brookside Fund is based upon 90,154,787 shares of Common Stock outstanding, which is the total number of shares of Common Stock outstanding as of May 30, 2008, based on representations made in the Company's Form 10-Q filed June 6, 2008 with the Securities and Exchange Commission.
